Subject: **Approval of training centre «CAE Training and Services» (Building 201 B-1820 STEENOKKERZEEL (Kingdom of Belgium)) and Recognition of their conformity to the Federal Agency of civil aviation requirements of the Russian Federation and Resumption of its approval.**

- The Federal Agency of civil aviation of the Russian Federation has considered the organizational arrangements of the courses, contents of the training programs and facilities used for the purpose of B757-200, B 767-300 pilots of the Russian Federation and come to the following conclusion:

- CAE Training and Services has been certified by NLCAA (approval number NL-TRTO-1/55, issued by on conformity JAR-FCL for all declared kinds of trainings);

- B757-200 full flight simulator is qualified for level D (Certificate number B-005) and may be used for pilots training;

- B767-300 full flight simulator is qualified for level D (Certificate number B-006/GE) with CF6-80C2-B6F engines and may be used for pilots training;

- B767-300 full flight simulator is qualified for level D (Certificate number B-006/PW) with PW4060 engines and may be used for pilots training;

- «CAE Training and Services» (Building 201 B-1820 STEENOKKERZEEL (Kingdom of Belgium)) corresponds to the requirements of Federal Aviation rules «Certification of the aviation training centers» and is issued an approval for 24 months from the date of issue of this document for Russian Federation pilots training in the Baltic Aviation Academy, for operation of B757-200, B 767-300 aircraft.
